

**WEST PLAINS PUBLIC DEVELOPMENT AUTHORITY
RESOLUTION NO. 2018-5**

**[Concerning Authorization for Certain Individuals to
Issue Checks and Make Payments]**

WHEREAS, Section 5.3 of the Corporation's bylaws authorize the Board of Directors to appoint certain individuals to "issue checks, drafts, or other orders for the payment of money, notes or other evidences of indebtedness" on behalf of the Authority; and

WHEREAS, pursuant to Section 3.7 and Section 6.6 of the corporate bylaws, the affirmative vote of a majority of the board members present, after a quorum has been found, is considered the action of the Board of Directors; and

WHEREAS, regardless of the authority listed above, Section 3.7 of the corporate bylaws nonetheless requires an affirmative vote of a majority of the Permanent Authority Board in matters regarding (a) debt, (b) approval of the Budget, (c) employment of the Authority executive director, (d) cost allocations made prior to issuance of Bonds; and (e) acquisition, sale, transfer, disposal, lease or conveyance of any interest in real property owned by the Authority; and

WHEREAS, this resolution replaces Resolution No. 2017-3 which had authorized certain individuals to issue checks and make payments; and

BE IT THEREFORE RESOLVED, in consideration of the authority and limitations outlined above, the Corporation's Board finds it desirable for the efficient and effective governance of the Corporation's affairs to appoint the following individuals as having the authority described in Section 5.3 of the corporate Bylaws:

Ben Stuckart, Board Treasurer

Al French, Board Secretary


