Minutes – Board Meeting

Meeting called to order 8:30 AM

Welcome and Introductions:

A roll call was conducted, and it was determined that there is a quorum.

Public Comment/Courtesy of the Floor:

Public Comment was requested by Board Chair Al French three times; there was no public comment.

Executive Director Chris Pengra requested that, due to the attendance of new board members, each person either on the board or staff member of S3R3 introduce themselves. He then asked Board Vice Chair Larry Krauter to give a brief history of S3R3 Solutions to which he responded accordingly. The overarching message was that S3R3's structure is unique to the state of Washington and that S3R3 will continue to leverage its structure to create economic benefits for the region through its economic development activities. It was recognized by several board members that S3R3 has multiple purposes including helping businesses navigate the development and permitting process, marketing the value of the Spokane region to potential businesses, and providing incredible service to all stakeholders involved within the County/City to develop vacant land available on the West Plains. A main point discussed and reiterated was that time kills deals. Therefore, it is imperative that S3R3 serve as a liaison and catalyst to progress development deals efficiently.

8:55AM – Board Member Garrett Jones joins the meeting.

Executive Director Chris Pengra began the discussion regarding the history and future of the PDA and asked specifically "why" each person serves S3R3. He gave his personal statement and asked the board members to do the same. Several stated their individual whys which could be surmised as follows: effect change, provide opportunities to achieve growth, bring jobs that create economic opportunity, equity, and provide pathways for advancement, to improve the lives of the people that live in the region, and showcase the amazing qualities of the Spokane region.

Executive Director Chris Pengra continued the board meeting by reviewing 2023, discussing the revenue sources for S3R3 and the overall financial performance. Note – the slides presented by Mr. Pengra will be included with the minutes. Please refer to the referenced slides for specifics.

Executive Director Chris Pengra presented the board with an overview of 2024 to include outward focus, target industry recruitment, advance current project and develop infrastructure funding strategy. The board focused on the opportunities with hydrogen with a focus on distribution, workforce availability, workforce development, the Tech Hub, Aerospace and defense industries, and other strategic targets. Action Item No. 1 - Consent Agenda

Board Chair Al French called for a motion to approve the Consent Agenda Action Item No. 1 which includes minutes for the October 12, 2023 regular Board Meeting and financials for September and October of 2023. Board Member Paul Katovich motioned for approval, Board Vice Chair Larry Krauter seconded, motion passed unanimously.

Executive Director Chris Pengra continued discussion with regard to the 2024 proposed budget. He thoroughly reviewed the projected spend. Board Secretary Greg Birchell asked for clarification regarding the \$1,510,000.00 projected for Sales Tax on New Construction income and asked if that was an accurate amount to speculate. Board Treasurer and CEO of Spokane County confirmed that as an accurate amount and S3R3 is correct in anticipating that dollar amount.

The board appreciated his attention to detail and made several positive comments and suggested that Mr. Pengra make adjustments throughout the year but the budget is a great reflection of S3R3's direction. Other specific comments regarding the budget were as follows:








STATEMENT OF PURPOSE

Real Property Tax

- PDA receives 75% of the incremental property tax increase over January 2018
- City of Spokane and Spokane County split 25% equally (12.5%/12.5%)

Personal Property Tax

- PDA receives 75% of incremental tax increase over January 1, 2018
- City of Spokane and Spokane County split 25% equally (12.5%/12.5%)
- Value decreases with depreciation of assets



REVENUE STRUCTURE

Revenue Sources

Sales and Use Tax

- Washington State Department of Revenue receives 1% administrative fee
- PDA receives 75% of any sales tax on new business (New business being any business not previously reporting sales tax within the PDA) minus Washington DOR administrative fee.
- City of Spokane and Spokane County split 25% equally (12.5%/12.5%)

Leasehold Excise Tax

- Washington State Department of Revenue receives 1% administrative fee
- PDA receives 75% of the incremental leasehold excise tax increase over January 1, 2018
- City of Spokane and Spokane County split 25% equally (12.5%/12.5%)

Utility Sales Tax

- PDA receives 75% of utility tax of the incremental tax increase effective January 1, 2018 with the 2017 base year
- City of Spokane and Spokane County split 25% equally (12.5%/12.5%)
